PLEASE READ CAREFULLY

1. PARKING TAGS/BADGES ARE NON-TRANSFERABLE AND MAY ONLY BE USED BY THE PARKER. PARKERS WITH MULTIPLE TAGS/BADGES MAY ONLY ACCESS THE GARAGE WITH ONE VEHICLE AT ANY GIVEN TIME.
2. THIS PARKING CONTRACT MAY NOT BE ASSIGNED TO ANOTHER PARTY.
3. SOME AREAS WITHIN THE GARAGE ARE DESIGNATED AS "RESERVED," "MOBILITY IMPAIRED," "COMPACT VEHICLE," "FUEL EFFICIENT VEHICLE" OR SIMILAR. UNAUTHORIZED OR IMPROPERLY PARKED VEHICLES ARE SUBJECT TO TOWING AT PARKER'S EXPENSE.
4. PARKER SHALL BE RESPONSIBLE FOR ANY AND ALL DAMAGE CAUSED TO THE GARAGE OR OTHER PARTIES WITHIN THE GARAGE.
5. ALL VEHICLES SHOULD BE LOCKED WHEN PARKED IN THE GARAGE WITH VALUABLES OUT OF SIGHT. OWNER, MANAGER AND OPERATOR ARE NOT RESPONSIBLE FOR ANY LOSS DUE TO THEFT, COLLISION, OR OTHER DAMAGE TO VEHICLES OR INDIVIDUALS. ALL PARKERS SHALL PARK AT THEIR OWN RISK AT ALL TIMES.
6. A REPLACEMENT FEE OF \$35+TAX IS CHARGED FOR LOST, STOLEN OR DAMAGED TAGS.
7. TAG/BADGE MUST BE PRESENTED TO THE CARD READER AT THE ENTRANCE GATE REGARDLESS OF GATE ARM POSITION. TAILGATING IS NOT ALLOWED, AND DOING SO MAY CAUSE ACCESS TO BE TERMINATED WITHOUT NOTICE.
8. PASS-BACK OF CARDS TO NON-PAYING PARKERS CONSTITUTES THEFT OF SERVICE. EMPLOYER WILL BE NOTIFIED AND PARKER ACCESS WILL BE TERMINATED IMMEDIATELY.
9. VEHICLE STORAGE IS STRICTLY PROHIBITED AND SUBJECT TO TOWING AT PARKER'S EXPENSE.
10. PARKER AGREES TO ADHERE TO ALL RULES AND REGULATIONS PERTAINING TO THE USE OF THE GARAGE. PARKER FURTHER ACKNOWLEDGES AND AGREES THAT 609 MAIN HAS THE RIGHT TO MAKE CHANGES TO THE PARKING AREAS WITHIN THE FACILITY WHICH MAY CAUSE THE AREA IN WHICH PARKER PARKS TO CHANGE, AT ANY TIME AND FOR ANY REASON. PARKER ACKNOWLEDGES THEY WILL NOT RECEIVE ANY REFUNDS DUE TO VACATION, ABSENCES, OR ANY OTHER REASON THEY FAIL TO UTILIZE PARKING SERVICES WITHIN THE GARAGE OR FACILITY, PER THIS AGREEMENT.
